Release and Waiver /Assumption of Risk and Indemnity Agreement (Please read and review carefully before signing)

In consideration of being permitted to participate in any way in any Kat's Adventures Limited event or activities (Event), I, for myself, my personal representatives, heirs and next of kin hereby agrees as follows:

1. I shall RELEASE, WAIVE, and DISCHARGE Kat's Adventures Limited, participants or any affiliate, subsidiary or subdivision thereof, sponsors, advertisers, owners and lessees of premises used to conduct the Event, premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or less control activities regarding the premises for EVENT and for each of them, their directors, officers, agents, members, and employees FROM ALL LIABILITY, LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENTS, WHETHER CAUSED BY MY OWN NEGLIGENCE OR OTHERWISE. In addition, I COVENANT NOT TO SUE KAT'S ADVENTURES LIMITED based upon any claim arising out of any of the EVENT, subject to clause 5 below.
2. I ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENT caused by me and I shall INDEMNIFY AND SAVE AND HOLD KAT'S ADVENTURES LIMITED HARMLESS from any loss, liability, damage, or cost they may incur due to claims brought against KAT'S ADVENTURES LIMITED arising out of my injury, or death, or damage to my property while I am participating in the EVENT and whether caused by the negligence of KAT'S ADVENTURES LIMITED or otherwise.
3. I hereby acknowledge that outdoor events are POTENTIALLY VERY DANGEROUS and involve the risk of serious injury. I hereby agree that this Release and Waiver, Assumption of Risk and Indemnity extends to all acts of my own negligence AND IS INTENDED TO BE AS BROAD AND INCLUSIVE AS IS PERMITTED BY THE LAWS OF ENGLAND AND WALES and that if any portion thereof is invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
4. I hereby ASSUME FULL RESPONSIBILITY for ensuring that I am in possession of adequate insurances policies, including travel insurance for provision of, but not limited to, medical emergency treatment, hospital and doctors fees, repatriation to my home country of me by medically appropriate means or in the event of death my body, personal liability, legal protection, as well as cover for travel delay loss of passport, cash or chattels in respect for participation in this event and I specifically acknowledge and confirm that such cover is appropriate for the countries, territories where the event will take place and specifically covers all activities in which I will participate. I hereby AGREE TO INDEMNIFY AND HOLD HARMLESS KAT'S ADVENTURES LIMITED in the event that any insurance provision is shown to be inadequate for the purposes of fully participating in this EVENT.
5. Nothing in this Release and Waiver & Assumption of Risk and Indemnity seeks to limit or exclude KAT'S ADVENTURES LIMITED liability for death or personal injury caused by its own negligence, or for fraud or fraudulent misrepresentation, or for any other liabilities that cannot be limited or excluded under English law.

I HAVE READ THIS RELEASE AND WAIVER, ASSUMPTION OF RISK AND INDEMNITY, POSSESSESION OF TRAVEL INSURANCE AGREEMENT AND I FULLY UNDERSTAND ITS TERMS AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
